

Letters of Acceptance have been posted from Kingdom and Laurel so, those with submissions pending, please check your emails for those. These Letters contain rejections as well and you must check these for sometimes the returns can be minor and with simple correction be resubmitted immediately for approval. Get with your submissions Herald on this.

Deciding on an SCA name for yourself and a device that best represents your persona can be a time consuming task by yourself. Seek the help of your Herald and Deputy Heralds to aid you in this process. Registering these items with Kingdom and Laurel can take time until the final decision making process is finished. Remember, you must have a registered name first to register a device or badge. Yes, these can be submitted all at once as well.

Household names and badges for such, can be submitted and are assigned to that person who submits the entry. Creating and registering these can also be very time consuming. I advise seeking out a submissions herald for these as well.

Should you wish to make submissions to Kingdom to register a name or device or even a Household name and badge, I would be more than happy to assist in this endeavor with you.


# **Greetings Ravens of the Cove,**

# Approval of minutes

The minutes of the January 2018 baronial business meeting were published for comment in the January edition of the Raven's Cry. Having received no comments or corrections, let the record reflect that the prior minutes stand as approved.

### Reports

Exchequer: Report given by Abrahm Polaski (Hlaford Vlfbeorn Ælfweardes sunu). There were some outstanding issues with the office; however, the review of the books is done, though we did not pass the review, it wasn't as bad as expected. There will be another review done within the next 12 months. We currently have \$3,932.79 in the account, however we still need send \$608 to the Kingdom as proceeds from University and we will need to pay for the Coastal Raids site by the end of the month. We need to have a few more people on the bank signature card to ensure that checks can be signed as needed. Mark Lane (Lord Lothian) and Dorothy Lopez (Lady

Dorothea) volunteered. Our financial policy will be completed by the end of April and brought to the populace for review and then to the Kingdom for approval. It will be further delineated in the financial policy, however, our financial committee will be all members of the populace present at a meeting when expenses are discussed and voted upon, with an emergency financial committee to consist of 6-8 members of the populace. The emergency financial committee will be used in cases when monies must be spent prior to a meeting of the populace.

Minister of Arts & Sciences: Report given by Morag Polaski (Baroness Olwen de Montgomery). There has been interest in having monthly A&S movie nights, but we still need to find an appropriate venue and date. Kingdom Arts & Sciences Fair is coming up in March, please attend if you can. James Barbour (Lord Eoghan) will be competing for Kingdom Brewer.

Chatelaine: Report given by Laura Garcia (Mistress Katherine de la Vache). The office will be moving to Angela Sanderson (Lady Arria Marina) officially at Coastal Raids, but Angela (Lady Arria) will be taking possession of the loaner garb and other Chatelaine boxes today. With our barony growing and a demo coming up please remember that everyone is a chatelaine.

Herald: Report given by Mark Lane Sr. (Lord Lothian ap Lyonesse). Lauren Smith Mayberry (Lady Rhiannon of Raven's Cove) has stepped down as herald, effective immediately. Mark Lane Sr. (Lord Lothian) will be the new Herald, with John Ipock (Lord Hrothgar) as his deputy. There has been a new Laurel Letter of Acceptance and Returns published, so if there are any questions about submitted devices, please ask.

Chronicler: Report given by Mark Lane Sr. (Lord Lothian ap Lyonesse). Please submit articles, photos, stories, songs, etc.

Knight Marshall: Report given by Jason Thomas (Lord Knutr Vakarsson). Kati Kameroski (Baroness Ingegerd Kastenrazi) is down with the flu, however, she plans to attend AEdult Swim in AEthelmearc to learn and bring back knowledge to put into practice here in Rayen's Cove.

Seneschal: Report given by Jason Thomas (Lord Knutr Vakarsson). He is excited to be seneschal of such a great group and sees lots of potential for growth within our group, especially now that we have some more territory in Duplin County.

#### Unfinished business

Coastal Raids (April 14-15, 2018): Abrahm Polaski (Hlaford Vlfbeorn) stated that the changeover from Seneschal to Exchequer has put him behind on planning for this event. We have a feastocrat ((Katy Polaski)(Lady Katheryn de Montgomery)) and a feast menu planned and posted on the event website. Feast budget is forthcoming. A&S competitions and rules have been posted on the event website. Site tokens have been ordered. The following event staff positions have been filled: Minister of the Lists – Morag Polaski (Baroness Olwen); A&S Coordinator – Morag Polaski (Baroness Olwen); "Nastycrat" – Brad Williams (Var); Marshall – Kati Kameroski (Baroness Ingegerd); Head Troll – Laura Garcia (Mistress Katherine); Hall Steward – Mark Lane Sr. (Lord Lothian). The fighting scenarios still need to be determined, but there will be a points-based Holmgang. Target Archery will be offered, with the Archery Marshall being Josie Von Krusze (Lady Alexandra), and thrown weapons is a possibility. Angela Sanderson (Lady Arria) has volunteered to put together a track of A&S classes at the event and will provide a day shade for these classes.

Strawberry Festival (May 11-12, 2018): Mark Lane Sr. (Lord Lothian) is heading up this demo at the Strawberry Festival this year. Word of the demo is spreading through the Kingdom

and there is a demo Facebook page. We can get in to set up on Friday afternoon/evening and be ready to go on Saturday. We will have both rapier and heavy fighting with Dave Dennis (Lord David of Raven's Cove) and Kati Kameroski (Baroness Ingegerd) acting as marshals. The idea of making favors for each fighter to hand out to the crowd was discussed, with Angela Sanderson (Lady Arria) making the suggestion of having an A&S night scheduled for the making of the favors in Raven's Cove colors so that the fighters could add their own colors to them.

National Night Out (August 7, 2018): John Romero (Lord Juan de Rojo) is heading up this demo. It was suggested that we do not have live fighting at the demo, given that the heat may make it dangerous for the fighters. Instead, having a computer running the video "SCA – The Dream" on a loop may be a better idea. This demo will be fleshed out closer to the date of the event.

### Motion

A motion was made for Mark Lane Sr. (Lord Lothian) to submit a bid and be autocrat for the 100% session of the University of Atlantia. The motion was made by Laura Garcia (Mistress Katherine) and seconded by Abrahm Polaski (Hlaford Vlfbeorn). The motion was carried by a show of hands of a majority of the populace.

A motion was made to spend up to \$100 on supplies to include, but not be limited to, envelopes, a banker's storage box, a deposit stamp, and a check cancellation stamp for the Baronial Exchequer's office. The motion was made by Abrahm Polaski (Hlaford Vlfbeorn) and seconded by Dave Dennis (Lord David). The motion was carried by a show of hands of a majority of the populace.

#### **New Business**

Baronial Birthday: Laura Garcia (Mistress Katherine) stated that she has been preparing to submit a bid for this year's Baronial Birthday (to have a Middle Eastern/Crusader theme) in March and encourages more bid submissions for this event.

### Announcements


