
### **Greetings, dear Ravens!**


## From the Seneschal

### Ravens' Record

(being the minutes of the Baronial business meeting of the Barony of Raven's Cove, SCA Inc.)

### Call to order

A meeting of The Barony of Raven's Cove, SCA Inc., was held at 309 Rock Creek South, Jacksonville, NC 28546 on May 19, 2019 at 2:53 pm.

### Approval of minutes

The minutes of the April 2019 baronial business meeting were published for comment in the March edition of the Raven's Cry. Having received no comments or corrections, let the record reflect that the prior minutes stand as approved.

### Reports

Exchequer: Report given by Abrahm Polaski (Hlaford Vifbeorn Ælfweardes sunu). The balance in the account is \$3,345.26. There is \$202 in pre-registrations for Nine Realms. There are still a few outstanding checks, including the one to Mount Olive for Unevent. We will re-issue the check to Mount Olive, minus the stop payment fees. The quarterly report is late, but the exchequer is working on it and the Kingdom exchequer is aware. The check for the site for Nine Realms has been received by the site. There has been no contact or resolution for the bounced check from Unbirthday. The exchequer is working on it. We need to have a list at troll for people from whom we will not accept checks. The books balance and we are doing well, especially considering that we have Nine Realms coming. Minister of Arts & Sciences: Report given by Morag Polaski (Baroness Olwen de Montgomery). Thanks to Baroness Edan for her Retaining 101 class. Our A&S meeting in June will be an open project night, and Mistress Morderyn has volunteered to teach a banner making class which will be held in July. Please send photos of your work to the MoAS so she can brag on you. August's class will be sheet walls for WotW, and September's class will be on the Baronial awards and how to write recommendations.

Chatelaine: Report given by Lord Knutr (Jason Thomas). We are seeing some old faces coming back and getting a few new ones. Everything is going well.


Herald: Report given by Lord Lothian (Mark Lane). If you have a name or device that you want passed, please talk to our herald. Things are moving slowly with the College of Heralds so please be patient. He would like to see sheet walls at WotW and we are discussing getting an A&S class for sheet walls scheduled.

Chronicler: Report given by Lord Lothian (Mark Lane). We suck because we don't send him photos. Baroness Edan has challenged the populace to write their origin story (what brought them to the SCA, etc.) and to send it to Lord Lothian by the end of May. Knight Marshal: No report given.

Seneschal: Report given by Lord Knutr (Jason Thomas). He is looking for a deputy and is taking volunteers. Freydis is interested in learning.

Baronage: Report given by Jim and Heather Rardin (Baron Lochlainn and Baroness Edan). Let's try to maintain our reputation for being helpful. At Nine Realms, once your stuff is put up, please help others get their stuff put up. The online baronial awards are now being forwarded to Their Excellencies. Before you submit an award recommendation, please check with the OP to see if they have the award. There have been a few recommendations for Order level awards without having the Award level award yet. When you write award recommendations please paint a picture of what the person has actually done, this should be a practice for writing for Kingdom award recommendations.



### Unfinished business

Nine Realms: The site has received our check, and once the event is over, we will get a \$200 deposit back. Our land coordinator would like a sprayer to mark lines on the ground. The backpack sprayer is \$133, the striping wand is \$162. In the long run, the backpack sprayer is going to be more cost effective. This could be a long-term investment. Mistress Katherine still needs people to help at Troll. Please take a shift. Marshal-wise, one thing might be changing. The thrown weapons challenge will now be a round-robin tourney. Lord Lothian will be bringing his golf cart for handicap assistance. We have 3 merchants pre-registered so far. The field will be set up on Friday. The folks at Optimist Farm are great to work with and are allowing us to get on site on Thursday. We discussed having a land agent for a baronial camp and Nezhka will be the land agent. Motions


A motion was made by Lord Lothian and seconded by lady Nezhka to purchase the backpack sprayer. The motion carried unanimously by a show of hands.
