### A Movie Review of Arn the Templar

Arn The Templar, or Arn the Knight Templar, is the English Cut of a Swedish movie and its sequel. The movies themselves are based off of a Swedish book series. The books are about the adventures of the fictional Arn Magnusson, and both them and the movie take place in the 12th Century.

The Movie starts off with Arn as a small child, and follows him and his love Cecilia throughout their lives. It has plenty of happy moments, but the movie mostly showcases Arn's and Cecilia's strength through their various tribulations. The story is very good, but nothing that will leave you speechless. The movie itself is dubbed over, with subtitles available if you wish to hear it in the original Swedish language. The dub is excellent, with no awkward sentences or word play. The scenes are well shot, with a refreshing lack of too much digital scenery. The fight scenes are very short, usually closing with a poignant shot of some object. The fighting is very well done, but you will be left wishing for a little bit more of it. This is a problem with foreign films, as their budgets are unusually small compared to American productions.

From a Medieval Enthusiasts perspective, the film represents how Europeans are excellent at filming medieval movies. It shows the Scandinavian cultures as advanced as any other European nation at that time, and not a bunch of anachronistic group of dark age Vikings. Armor shown close up appears to be of excellent historical correctness. No obvious pieces of armor from other centuries, almost all correct for 12th/13th century Europe. Arn in particular seems to wear a riveted hauberk for most of the movie, though it is hard to tell if it is truly metal. Fighting in the movie is aimed at being realistic, with no "300" style fighting. There is a refreshing lack of "ye olde dirty peasants" in most of the film, with peasants wearing at work and leisure well fitting and historically accurate clothes. While the intrigues are a little unsubtle, play well at the old themes of noble dynastic intrigue. Also of note is the showing of an convent in the film, and showcases the power held by the abbess, and through her the power of the church of old.

All in all, Arn the Templar is nothing spectacular, but a very good medieval movie none the less, made even more so for its tiny budget. I recommend to any Scadian wishing to enjoy a modern made movie placed in the period.
