



Our intentions are to serve as long as the populace deems we worthy and supports us with their votes of confidence.






Baron Torquil & Lady Amira

Q & A

1. Why do you want to be Baron & Baroness? What is the most important goal you have while you wear the coronets?

We feel like we have a lot to offer the Barony and the Kingdom. We wish to help promote everyone in the Barony and help everyone find their niche. It's also important to make sure everyone in the populace is recognized for their works.

2. What is the most important single attribute you feel you as a couple bring to the table?

Blending over 20 years of experience in the SCA and the lively perspective of someone fairly new gives us a unique force to direct the Barony.

3. What do you believe the key responsibilities are for the Coronets of Raven's Cove and how do you plan to fulfill them?

Keeping the populous happy, recognizing the works of the populous, growing the Barony, and serving the Kingdom and Society are all key responsibilities. We plan to fulfil them by staying in direct contact with the populace as well as close touch with Their Majesties and Highness. As far as expanding and growing the Barony, we have plans already in development to begin marketing ourselves more in the coming years.





4.The SCA can be divided into 3 disciplines: martial, arts & sciences, and service. Since all the candidates have shown their expertise in service, what experience do each of you have in the other two disciplines?

Even though Torquil is unable to fight anymore due to health issues, he has over 20 years' experience in combat and battles. He has been the Barony's Knight Marshall and has literally trained hundreds of perspective fighters over the years. He still attend fighter practices to lend a hand where may be needed. Amira has helped on many armor projects such as creating a new brig and painting new shields. As far as Arts and Science, Torquil is, of course, a Laurel and Amira has entered many A&S competitions, winning two of them so far. She is also working on her first Pentathlon in Persona for this years Kingdom Arts and Science Festival.

5.Do you intend to replace champions/notables immediately or ask them to stay on for a time?

Traditionally, we change out champions at Baronial Birthday every year. After speaking with the current champions, we may retain a few of them for another year.

6. What are the Barony's three greatest strengths and how do you plan to use these strengths?

The Barony's three greatest strength are our family structure (once a Covian, always a Covian), willingness to serve and dedications of individuals to their specific art form. We plan to continue these strengths and help other find their niche within the Barony.

7.On average, how many events do you expect to attend per month? What major wars will you attend?

Generally, we try to attend one to two events per month. Some months may be more, but that is a general number. We will of course be attending War of the Wings and possibly Pennsic. Family issues have prevented us from attending Gulf Wars this year as originally planned but we will be attending it sometime in the next few years.





8. How will you handle disaffected or burnt out populace?

Sometimes people are burnt out on a specific job but not the SCA in general. It just requires recognizing the issue before problems occurs and helping to move that person to something more refreshing for them so that they don't become negative or disaffected.

9. What real world practical experience do each of you have in leading and motivating people?

Torquil runs crews of up to 15 people every day at work and not always under the best of circumstances. He's been in management for over 20 years in his industry. Amira has also been in management for over 20 years and has been an Operation Manger for a large financial corporation with over 600 employees under her. She is experienced in marketing and event planning on a large scale with both her job and non-profit organizations, relying on the help of many volunteers to get the job done.

10. How long would you like to serve as Baron & Baroness? For as long as it's fun and we are effective.

Q & A

1. Why do you want to be Baron & Baroness? What is the most important goal you have while you wear the coronets?

We both love Raven's Cove. We started our SCA life in the Barony, and it would make us so very proud to lead the family we have come to know during our time in the SCA.

We both feel that our most important goal is to lead the Barony in growth, not only in land but in populace as well. This growth would most assuredly lead to an increase in fighters of all disciplines, and in more of a presence throughout the Kingdom during events.

Secondly, if we can go one further in most important goals, we also feel it is important that each member of our barony feel involved and can thrive through either their own actions or with the help of great leadership that exists within our group.

2. What is the most important single attribute you feel you as a couple bring to the table?

Solidarity. We most definitely do not always have the same opinion on matters, but as a couple we have developed the ability to work together to find the best middle ground to every scenario that we deal with.

- 3. What do you believe the key responsibilities are for the Coronets of Raven's Cove and how do you plan to fulfill them?
- a. The coronets are representatives of the Crown and our job is to be a bridge between the populace and the Crown, and when called to do so, present the wishes of the Crown to the populace and at the same time ensure the needs of the populace are met. As representatives of the Crown, it is our duty to put first the needs of our people and act in a manner that will only further the greatness that is the Kingdom of Atlantia. The coronets are expected to be a presence at as many kingdom events as possible, making themselves

accessible to Their Majesties, Their Highnesses and all other officers of state not only to handle the business of the kingdom but to ensure an excellent relationship with all entities that exist within our kingdom. b. To understand how incredibly important the populace is and how important it is to make sure that their wishes are always considered in all decisions. A barony cannot survive without people to help run it. This organization cannot exist without those that dream about its existence. It is very important to listen to the individuals within your populace and utilize every opportunity to support their interests and skill. If someone comes to you with a talent, it is your job to try and offer them a path at which they can excel in it. The kingdom exists on the dreams of its people and the baronage are the forefront of ensuring that the dream lives on with every single new person that graces our groups. And if their dream changes, aid them in selecting another way.

Introduce them to people that can help them be what they want to be and urge them to make many friends to help them along the way. Even if that means that they must venture beyond our borders, our job would be to show them the way no matter where they may roam.

c. Baronage is also responsible for supporting the disciplines that exist within our kingdom, whether we are part of them or not. These things also contribute to the dream and give people goals to work towards. There is nothing better than to sit in court and watch as people are recognized for hard work. This kingdom exists because of accomplishments of its people in these disciplines and it is the duty of the coronets to support these disciplines as much as possible. Not only in their respective areas but with all the work that goes on in the path leading to them.

4. The SCA can be divided into 3 disciplines: martial, arts & sciences, and service. Since all the candidates have shown their expertise in service, what experience do each of you have in the other two disciplines?

Lochlainn is an accomplished armored fighter in his own right, being a Squire to Duke Bryan, and fighting in numerous Crown Tourneys. He is also an authorized Rapier fighter, and is working towards an authorization in Siege. He has been awarded a Silver Nautilus for his chair making, and has started to take over Mead making from Baron Calledon by using the Hallborne recipe.

Edan is also an authorized fighter in the Combat Archery and Equestrian arenas. As far as A&S goes, she has made numerous pieces of jewelry. The jewelry she has made has been not only for personal wear by individuals, but has been used as largesse by numerous Crown wearers.

5. Do you intend to replace champions/notables immediately or ask them to stay on for a time?

As it has been a tradition to name Champions during our Baronial Birthday, we too would continue this tradition. We would like to see other areas addressed as we have not had an A&S Champion in the past, and hope that we would have a chance to choose not only an armored and an archery champion, but a rapier champion as well.

- 6. What are the Barony's three greatest strengths and how do you plan to use these strengths?
- a. Its people, without a doubt. The people of our barony are some of the most open hearted, hard-working and wonderful individuals we have ever had the privilege of knowing. There is such support here in our little group that there is nothing we cannot accomplish, as we have shown time and time again. We are so very proud to be a part of this group and to represent them will just further that pride.
- b. Its tenacity. There is nothing that can hold us back and no matter what challenge is set before us, we will always ban together, despite all differences and come out victors. We have had many challenges we have faced and yet we not only survive but we THRIVE. In a military town, with a high turnover of people, that is very difficult but somehow we always remain.
- c. Our group has done monumental things for the kingdom. Over the years we have had several people either serve or attempt to serve in key kingdom positions. Many times, we have taken the lead in doing jobs most people would run away from. Most of our populace has been recognized by the kingdom for their great deeds. Again, we are simply put, the "little barony that can". Within our borders there exists people that have been authorized in many different areas of the martial arts and there is evidence of crossover from one of the key disciplines to another in some individuals. For example, we have a couple of heavy fighters that are Pelicans, we have a fighter that is a Laurel and so on and so forth. With as small as a group as we have, that only shows our willingness to participate and excel in the fruition of the dream.
- 7. On average, how many events do you expect to attend per month? What major wars will you attend?

We expect, as in the past, to make the attempt to attend at least one kingdom event per month. Hopefully most of these will be attended by both of us together but we realize with work and the mundane world in general this is not always possible but we have begun making plans for at least one of us to be in attendance at one event per month.

At this time, due to family obligations, we do not plan on being at Gulf Wars or Pennsic War. We do plan on attending Gem Joust and WotW though.

8. How will you handle disaffected or burnt out populace?

We would hope that any individuals who feel that they may be approaching to point of burn out would feel comfortable enough with us to bring that issue to our attention. If they did, we would try to help either refocus them into areas that they may hold more dear. We would also not be against advising individuals to step into the background if need be to take a break and come back with a fresh outlook and renewed interest. In the end, each member of the populace must follow their own heart, and while we hope that path would keep them within our SCA family, we realize that sometimes this is not the case.

9. What real world practical experience do each of you have in leading and motivating people?

Lochlainn has been in the United States Marine Corps, achieving the rank of Gunnery Sergeant before retiring at 21 years of service. His main focus was the bettering of his marines under his watch and always striving to bridge the gap between enlisted and officers. He also has served as the Assistant Chief of a local volunteer fire department, working his way up through the ranks from firefighter, through officer and finally a chief position. He also served as the training officer of this department at various times and was an excellent mentor to new firefighters. In being an officer, he was in command of different calls varying from motor vehicle accidents to structure fires. He continues to be a mentor in his paid department even though his time as a volunteer firefighter has ended. He is also an NC EMT and is proficient in his skill. He has served as the Knights Marshal of the barony, offering instruction and multiple training aids and opportunities for up and coming fighters. He trained our newest Knights Marshal, who is doing an excellent job! He is always offering advice to anyone that solicits it and pushes others to step outside their comfort zones in their pursuit of their version of the dream.

Edan has also served as a Captain in a volunteer fire department and has mentored new firefighters. She at times

also has been in charge on a call with the same variables previously stated. Although she is not currently with a volunteer department she has since devoted her

time to educate the general public about fire safety, serving on the Onslow County Firefighters Association as well as the newly found Jacksonville/Onslow Volunteer Group. She has headed an event here in Onslow County called "Fire Prevention Kickoff", held each October and one of her events was recognized on a national level by the NFPA (National Fire Protection Agency). The agency contacted the local fire marshal and she was tasked to create a document illustrating the planning of the event to be used as a guideline for other entities in their endeavors for fire education. Her newest project is trying to bring a local food bank to our area for under privileged individuals, focusing on the very young and elderly. She has taught a "Remember When" class that teaches the public about dangers for the elderly that could exist within their homes and how to avoid potential accidents. She has a background in customer service with a transportation company, where she was employed for 10 years, working closely with the United States Marine Corps. She has also coached a parks and recreation cheerleading squad for a consecutive 3 years in the past and at one time, was coaching two different squads of two different age groups as the same time.

We are also the parents of a combined family consisting of a total of 8 children (ages ranging from 11 years old to 21) and currently, Edan is not working outside the home so she can support the needs of the children with regard to extracurricular activities as well as carry on with volunteer work.

10. How long would you like to serve as Baron & Baroness?

Most definitely we would serve for the three initial years that come with the position. At the end of that period we would most definitely be guided by the wishes of the populace as to continuing or to step down.
