Ravens' Record

(being the minutes of the Baronial business meeting of the Barony of Raven's Cove, SCA Inc.)

<u>Call to order</u>

A meeting of The Barony of Raven's Cove, SCA Inc., was held at 309 South Rock Creek Drive, Richlands, NC 28574 on January 12, 2020 at 2:29 pm.

Approval of mínutes

The minutes of the November 2019 baronial business meeting were published for comment in the December 2019 edition of the Raven's Cry. Having received no comments or corrections, let the record reflect that the prior minutes stand as approved.

<u>Reports</u>

Seneschal: Report given by Felicia Padgett (lady Freydis Rodmarsdottir). Reports have been submitted.

Exchequer: Report given by Abrahm Polaski (Hlaford Vlfbeorn Ælfweardes sunu). The Doomsday is not done, but won't be difficult, the current balance is \$5,681.94. His warrant is up at the end of the month, however, Vlf will extend until a replacement is found, within a reasonable time.

Chronicler: Hrothgar is supposed to take over the newsletter, but Freydis will check on that.

Minister of Arts & Sciences: Report given by Morag Polaski (Baroness Olwen de Montgomery). The year-end report has been submitted, and we are good on that front. This coming Thursday is A&S Night at Michaels, where His Excellency will be speaking on event etiquette and households.

Chatelaíne: Report given by Josie von Krusze (Lady Alexandria). She has taken possession of the Gold Key but is not currently "officially" the chatelaine.

Freydis and Alexandria will discuss how to get the warrant done and approved.

Herald: Report given by Jim Rardin (Baron Lochlainn). There hasn't been a new letter sent out, but one is expected next month.

Marshals: Report given by Jim Rardin (Baron Lochlainn) and John Romero (Lord Juan). The quarterly report is done. We have had no new authorizations. However, the state of the marshallate is as follows: Alexandria's warrant is up next year, Her Excellency is good, Mistress Mordrea has a membership renewal, Lord Juan needs both class and membership, His Excellency is good. Lord Juan is waiting on a background check for youth combat. It would be nice to see all the fighters/marshals up their game by gaining one more authorization or marshal qualification.

Baronage: Report given by Jim and Heather Rardin (Baron Lochlainn and Baroness Edan). The upcoming birthday will be Their last one with having morning and evening courts. Please submit any recommendations to Their Excellencies as soon as possible. Please submit them through the Kingdom award system, but please email them to let them know that it's in the pipe. They would like people who are wanting to be on the polling to get Them ideas for the theme of the investiture by Kingdom Twelfth Night (January 18). They are serious about this. The wish the new baronage to have the best possible day they can. They will bounce ideas off each set of candidates as the planning goes on.

Unfinished business

Baronial Birthday: Freydis has the new bid/budget form, but needs to start working on tokens, getting with folks for newcomers activities etc. She is looking for prizes if the populace has anything they wish to donate. There will be an A&S night for making site tokens. The total cost proposed is \$454.00.

Sites: We are currently trying to find fighter practice sites in other counties within the barony. The old Miracle Meadows stable was floated as a potential event site last meeting but was determined to be unsuitable due to the primitiveness of the site. Ashley has stated that the multipurpose room at the Ag Extension in New Bern is a possibility for a non-fighting event.

<u>Motíons</u>

A motion was made by Ashley Brooks (Nezkha Orshinaia) and seconded by Josie von Krusze to accept the proposed budget for Baronial birthday and passed unanimously. A motion was made by Abrahm Polaski (Vlfbeorn Aelfweardessunu) to pursue the City of Jacksonville Jamboree as a potential demo and get more information. The motion passed unanimously.

A motion was made by Heather Rardín (Edan Lowery) and seconded by Abrahm Polaski (Vlfbeorn Aelfweardessunu) to hold the Agincourt event in April 2021. The motion passed unanimously.

<u>New Busíness</u>

Archery: Lord Juan is looking for an archery site, in the meantime, his backyard is always available.

Rapier: Lord Juan has been offered the use of his neighbor's yard for rapier practice.


Jamboree: This is sponsored by the City of Jacksonville and will be the same weekend as Crown. Lord Juan is trying to get up with the organizers to see if we can do a demo there.

Upcoming events: Their Excellencies wish to autocrat an event in April 2021, which is an archery themed event based on Agincourt. Her Excellency will autocrat it, and His Excellency will be the feastocrat. The feast will consist of game that could be brought down by archers. Feast will be done old school style with servers and banners and the like. They would like it to be at Optimist Farm and there is not a thing on the calendar as yet, with a potential date of the 2nd weekend of April, giving the new monarchs a good first event. The cost to do the event (roughly) is \$2915, with an expected profit (with 300 people in attendance) of \$2000. This would be run as a Raven's Cove event, not as a household per Society law.

Next Meeting: February 9, 2020 at 3 pm, officers meeting at 2 pm at Michaels.

<u>Adjournment</u>

There being no further business to come before the populace, the meeting was adjourned at 3:33 pm.
